General Guidelines MMTA DISTRICT EVALUATIONS AND STATE FINALS

I. <u>DISTRICT EVALUATIONS</u>

A. Requirements & Scheduling

Teachers entering students in the MMTA Pre-College Evaluations must be members of the Mississippi Music Teachers Association and Music Teachers National Association. Membership dues must be paid by the date established by the MMTA Board to be eligible to enter students in any Evaluations or Competitions. Teachers entering students must work at District Evaluations or pay a fee to be determined by the district. Teachers who have students in State Finals must work a minimum of ½ day or pay \$35 or the fee determined by the MMTA Board. Teachers will provide a list of students who will play in the State Finals to the VP of Pre-College Competitions.

District Evaluations will be held on the first and second Saturdays in April. If this conflicts with Easter, the Evaluation dates will be scheduled at the discretion of the VP of Pre-College Evaluations, with District Evaluations in March and/or April, and State Finals in May. Dates for Evaluations and State Finals should be confirmed in May for the following year. Districts will be divided into two groups with one group holding evaluations on the first designated Saturday, the other on the later date.

Group A: Cleveland, Jackson/Goodman, Hattiesburg, Oxford, and will audition first in even-

numbered years.

Group B: Ellisville, Gulf Coast, Columbus/Starkville/Tupelo, and Vicksburg will audition first in

odd-numbered years.

Students who cannot attend MMTA District Evaluations in their own district may participate in a different district. No other make-up evaluations are allowed.

B. Guidelines for District Evaluations

Students will be evaluated by a qualified adjudicator who will give a written evaluation and a numerical rating. Evaluation shall include commendations for elements well done, and constructive comments where attention is needed. Ratings are **SUPERIOR** (90-100), **EXCELLENT** (80-89), **GOOD** (70-79), **NEEDS IMPROVEMENT** (60 – 69). There will be no scores below 60. Judges will be carefully instructed in procedures prior to beginning adjudications.

Performance

Repertoire requirements are listed separately for each instrument and level under **Requirements**. Time limits are strictly observed. Only original music may be used, with the exception of **Piano Ensemble**, **Guitar & Voice** – **all Grades**, **Strings**, **Brass** and **Woodwinds** – **Grades 7 & Below**, for which arrangements will be accepted. No photocopied music may be used by the soloist, the accompanist, or the judge. The use of computer-generated music (i.e. music from CD rom from publisher) is permitted only if the music contains copyright information.

Vocal and Piano students are required to have repertoire memorized.

Guitar, Brass, Strings and Woodwind students are not required to have repertoire memorized – optional.

Voice students will be evaluated on the following: stage presence, vocal technique (including accuracy of pitch), musicianship and interpretation (including the ability to demonstrate understanding of lyrics/poetry). Evaluation shall include commendation for phrases well done and comments where attention is needed.

Sonata/Sonatina

Judges will hear sonatas/sonatinas consisting of at least 2 movements. Memorization required for pianists.

Theme & Variations

Judges will hear the entire work consisting of a theme and a minimum of two variations. Memorization required for pianists.

Ensemble

Students will perform one duet, duo, or other ensemble composition with no repeats. Each ensemble must enter the level of the student who is in the highest Grade. Memorization is *not* required.

Technical Skills

Judges will listen to designated requirements from each area within the allotted time on the Adjudication sheet. Time limit includes writing comments.

Sight-Reading

(Optional for Voice) Judges will listen to three (3) short examples provided by VP of Pre-College Evaluations. Testing of Sight-Reading should not exceed five (5) minutes, including writing of comments.

Written Theory

(Optional for Voice) Students in the same grade will be tested as a group whenever possible. Students may repeat the test at the same grade if they are permitted by grade in school to remain on that grade.

II. SPECIAL INFORMATION

A. Grades

Students are encouraged to participate in their school grade. Students who have skipped a grade academically may choose to enter at that grade or at the grade that their birth year reflects.

B. Non-Competitive

Non-competitive students are those who participate in any grade lower than their grade in school. Their evaluation scores are based on the student's performance, regardless of their grade or years of study, but they are *not eligible* to perform at State Finals. Non-competitive students will receive adjudication forms and a certificate.

C. Accelerated Grades

Students who enter a *higher grade* than their grade in school are eligible for State Finals, but if they win that grade, they must move up a level the following year to be eligible for State Finals in that year.

D. State Finals Winners

Pre-College Final winners must move up a level the following year. A student may not be a winner at the same grade for two years, except for **Grades 3 & Below** and **Grade 12**. These advancement rules apply to Piano Solo Performance only.

E. Special Needs

Special needs apply to a student who needs special exceptions to the General Guidelines. A student of any age may require assistance in reading the written theory test or need more time to complete the test. A physical condition may require special considerations such as wheelchair accessibility, or scheduling. The District Evaluations Chair(s) will work with the student's teacher to determine how MMTA can best serve these students. Special needs students performing at their *grade* may participate in State Finals if their scores meet eligibility requirements. No words or markings will appear on adjudication forms or certificates that indicate special needs.

F. Multiple Ensemble Registrations

To register in more than one Ensemble, a student must be eligible for *each* Division entered, and play *different* repertoire with a new partner.

G. Duplication

Students performing in **Sonata/Sonatina** and/or **Theme & Variations** Divisions may *not* program any part of those works in **Solo Performance** at District Evaluations or State Finals.

H. Divisions

Students entering Sonata/Sonatina, Ensemble and Theme & Variations will be grouped into Divisions, according to their grade.

I. Repertoire Changes

Students will be allowed to change repertoire up to 7 days prior to the District Evaluations. If they choose to do so, it is the teacher's responsibility to provide a replacement application 7 days prior to District Evaluations. The new application must be in the District Evaluations Chair's hands 7 days prior to the Evaluations entered. **Students may** *not* **change their repertoire between the Evaluations and State Finals**. If students change their repertoire at that time, they will be declared ineligible for competition but will be allowed to play and receive a rating and certificate. Original repertoire will appear in the State Finals Recital Book.

J. Recourse Policy

If an error in Grading or Computation is found on either Written Theory or Technical Skills the teacher must notify the District Evaluations Chair within 24 hours of the end of the Evaluations, except for students playing outside their district. Otherwise, there can be no recourse for errors made. When students play outside their district, the chair must allow time for teacher's receipt of the student's evaluation forms.

K. Deadlines

Published entry deadlines for District Evaluations must be adhered to without exception. There will be no refunds in the event of cancellation.

L. Outstanding Achievement Award

This award recognizes students who have demonstrated excellence in music and perseverance through participation in the District Evaluations. Applicants must have been eligible for State Finals seven different years (not consecutive). Five of these years must be in Solo Performance. State Finals eligibility in multiple categories within the same year will count as *one* year. Recipients shall receive an engraved plaque and a monetary award at State Finals. A student whose first year of participation in Evaluations is as a Non-Competitive student may apply that successful participation toward the Outstanding Achievement Award if their scores meet State Finals requirements. This would apply to a Grade 4 who enters Grade 3, or a Grade 5 who enters Grade 3 or Grade 4 their first year.

Procedure: Teachers recommending students for this award must submit to the District Evaluations Chair(s) the completed application and documentation of student's seven years of eligibility no later than the date of the current year's Evaluations. (Copies of Adjudication sheets, Certificates, State Finals Winners' Recital, or State Finals programs are acceptable.) The District Chair(s) will send the application and documentation to the VP of Pre-College Performances with the results of the current year's Evaluations. Students may receive this award only once.

III. STATE FINALS

A. Date

State Finals will usually be the first weekend in May. Refer to the MMT for the exact date and place.

B. Eligibility

To be eligible for State Finals, students must achieve the required ratings for their grade as stated for each performance category and/or medium entered in the District Evaluations. Students must receive a Superior rating in various combinations of the 4 basic categories: Solo Performance, Technical Skills, Written Theory, and Sight-Reading. Requirements to be eligible for State Finals for each grade and medium are listed below:

C. Performance Time Limits

Students in Solo Performance will perform two contrasting pieces as indicated on the District Evaluations Application. If no repertoire is checked, the first two compositions listed will be programmed. If repertoire exceeds the time limit, the student will be stopped by the monitor. Teachers and students must be aware that both pieces are to be heard by the judge(s) within the time limit allowed for that level. Otherwise, the student will be ineligible for an award. Students are advised to play the shorter piece first. Taking repeats is discouraged. A timekeeper will stop any student exceeding the limit, but students stopped during the second piece will not be penalized.

Sonata/Sonatina: 10 minutes

At the State Finals, students will *play only two contrasting movements*, with no repeats except for *Da Capo*. If more than two movements are performed, students will be disqualified from the **Sonata/Sonatina** competition. No portion of this composition may be programmed for **Solo Performance**.

Theme & Variations: 8 minutes

Students will play a complete **Theme & Variations**, with no repeats. However, should the composition exceed the time limit, students may choose contrasting variations that will fill the allotted time. No portion of this composition may be programmed for **Solo Performance**.

Ensemble: 5 minutes

Students will perform one duet, duo, or other **ensemble** composition, with no repeats. Each **Ensemble** must enter the level of the student who is in the highest grade.

D. State Finals Repertoire Restriction

Students are not allowed to use the same repertoire which they performed at previous District Evaluations or State Finals. They must perform the repertoire indicated on their application form. In the event of a discrepancy with the program booklet, the announcer will verify the piece(s) with the Workroom before awards are presented. If students have performed the wrong piece, they will be disqualified from receiving an award.

Suggested solo literature (for all levels and instruments) is available from all chair officers. The ultimate choice of literature is at the discretion of the teacher.

E. Accompanists

Students whose pieces require accompaniment may provide their own accompanist, or MMTA will provide contact information of available accompanists for State Finals at the request of the teacher.

IV. State Finals Awards

A. Medals

Medals shall be awarded to the winner(s) in each Grade/Division recital at State Finals. The student receiving the highest averaged score in each Grade/Division shall be declared winner. In case of a tie, duplicate awards shall be given. (Pre-College Concerto and Original Composition winners' medals will be presented at the MMTA State Conference in the fall semester.)

B. Ribbons

Ribbons shall be awarded to all students who receive an average of 95 or higher. Scores above 95 will be ranked in descending numerical order, with ribbon awards being given to Second, Third and Fourth places. All other students who are non-winners but receive a rating of 95 or higher in their performance shall be awarded an Honorable Mention. Students whose scores tie will receive duplicate awards. Students who received the highest composite score in the four basic categories will receive a ribbon at State Finals.

C. Certificates

Certificates of Participation shall be awarded to students who participate in any category of the State Finals.

D. 360 & 270 Certificates

Students in Grades 4 & Higher and Grades 3 & Below who scores of 360 and 270 or higher respectively at local District Evaluations will receive a special Certificate at State Finals.

E. Outstanding Achievement Award

V. <u>JUDGES' GUIDELINES</u>

A. State Finals

Students performing at State Finals have already participated in District Evaluations where they were judged Superior in Performance and met other stringent qualifying tests which vary by grade and medium.

At the State Finals, one judge shall judge each recital in Guitar, Brass & Woodwinds, Strings, Voice, or Piano. For Solo State Finals events, each student must perform the two memorized selections designated on their Evaluations Application Form, within a specified time period, which varies by grade and medium.

Judges shall give each student a numerical grade (1-100). The student with the highest grade will be declared winner in each Grade and Division. In case of a tie, duplicate awards will be given. Students who receive a grade of 95 or higher will be ranked 2nd, 3rd, 4th Place, or Honorable Mention in descending order from the winner. Certificates of Participation will be awarded to each student who plays in any category of State Finals.

Score sheets will be collected at the conclusion of each recital and delivered to the workroom for ranking and record keeping.

Sonatina/Sonata division performances will perform only *two* movements.

Theme and Variations must be played in their entirety. (Should the Theme & Variations exceed the time limit, the student may choose contrasting variations to fill the approximate time limit.)

Ensemble entrants are *not* required to perform by memory.

Each performance will be timed, a timekeeper will stop any student exceeding the limit, but students will *not* be penalized. However, a student must play at least portions of two selections to be eligible for an award. Judges should note on scoring sheet if only one piece was performed. Likewise, a student playing three movements of a Sonata/Sonatina will be ineligible for an award. The purpose of our State Finals is to support and encourage music study by every student in the recitals. Please keep in mind that you are judging Pre-College students. Only a small number will be of outstanding ability and continue to advance music study. Many are not musically gifted but demonstrate diligent preparation. We seek to recognize and reward their commitment by presenting several awards in each recital.
